COM approved request for lay and clergy to serve and assist in worship at The Presbyterian Church in Traverse City having been trained by Rev. Bill Myers. Explanation follows:

As part of the preparatory process, each of the elders will attend two sessions, conversations on the theology and meaning of "Worship, Preaching, and the Lord's Supper" and "Putting it All Together" (preparing for and presiding over worship). As part of these sessions, I am introducing the participants to our "Directory for Worship" (Book of Order) and "The Book of Common Worship". I will provide additional support, as needed.

Rationale: The most recent Book of Order allows for "specific ruling elders to administer or preside at the Lord's Supper when it [presbytery] deems it necessary to meet the needs of the administration of the sacrament."
