

**PROPOSED MINUTES

1 The Presbytery of Mackinac held a Stated meeting Saturday, February 22, 2020. Presbytery Moderator, Ruling Elder William Clark called the meeting to order and opened with prayer at 10:00 a.m. at First Presbyterian Church of Elk Rapids, Michigan.

1.3 First-time ruling elder commissioners and pastors new to the Presbytery were introduced and welcomed.

1.4 On motion duly made and seconded, Presbytery **VOTED** to give Corresponding Members voice but not vote.

- 5.1 The Rev. Dr. James Porter, pastor of First Presbyterian Church of Elk Rapid, Proclaimed the Word of God, “You Are the Light of the World!” based on Matthew 5:13-16. The Rev. Dr. Porter and the Rev. Jaime Klinger, Designated Pastor of First Presbyterian Church of East Jordan, co-officiated at The Lord’s Supper.
- 5.2 **COORDINATING COUNCIL**
Coordinating Council Chair, Rev. Dr. William Myers, reported.
- 5.3 A minister member has a child who is in need of treatment and the Presbytery has entered into a partnership with the Board of Pensions to help fund it. He invited prayer.
- 5.4 The pastor and office administrator of First Presbyterian Church of Petoskey will be sharing space in the Presbytery office while their space undergoes renovation.
- 5.5 He shared a letter received from the General Assembly Administrative Commission related to their work with the Synod of the Covenant. Before reading the letter, he stated that he would not entertain any questions or comments because this is the only information the Presbytery has received at this time. As of February 14, 2020, 35 of the Presbytery’s thirty-nine (39) churches have completed the 2019 Session Annual Statistical Report.

6.1.3 Report of the Council's (Presbytery's) Annual Review of Session Records (G-3.0108)

Final Report of the Annual Administrative Reviews for 2018-2019 that were conducted and completed for 32 of the 39 churches in the Presbytery.

A review of the Administrative Review Forms shows the following:

Bellaire, Dafter, Donaldson, Florence (Wisconsin), Gould City, Hessel, Houghton, Petoskey were approved without exception.

Alpena, Beulah, Big Bay, DeTour Village, East Jordan, Elk Rapids, Escanaba, Gaylord, Harbor Springs, Harrisville, Iron River/Iron County, Kingsford/Iron Mountain, Manistique, Marquette, Neebish Island, Newberry, Pickford, Rogers City, Sagola, Sault Ste. Marie, Spruce, Stalwart, Northern Lakes Traverse City, and Traverse City were approved with exception.

Boyne City, Ishpeming, Menominee, Munising, Omena, Rudyard, and Trout Creek are non compliant.

6.1.4 224th General Assembly (2020)

From June 20-27, 2020, "commissioners and advisory delegates from 170 PC(USA) presbyteries and other delegates and observers from around the world will converge on the Baltimore Convention Center in downtown Baltimore for celebrations, deliberations, and inspiration in support of the denomination's biennial gathering." This website, <https://www.pc-biz.org>, includes the most current text of the overtures and other recommendations that have been forwarded to the 224th General Assembly. As of February 14, 2020, there are 42 items of business posted. Available is the Manual of the General Assembly and the Participants List.

6.1.5 Mid Council Leaders Gathering (formerly the Fall Polity Conference) and Association of Stated Clerks Meeting and Association of Mid Council Leaders Meeting

The Stated Clerk attended the Mid Council Leaders Gathering October 18-20, 2019, and the Association of Stated Clerks and Association of Mid Council Leaders Annual Meeting October 20-21, 2019, at the Renaissance Harborplace Baltimore Hotel in Baltimore, Maryland.

The Mid Council Leaders Gathering, co-sponsored by the Office of the General Assembly and The Board of Pensions of the Presbyterian Church (U.S.A.), is designed for presbytery and synod executives and stated clerks.

The Mid Council Leaders Gathering is an opportunity for mid council leaders and staff of both sponsoring agencies to engage with one another in a collaborative environment to learn about polity issues; discuss benefits issues related to polity and partnership; share common concerns; discuss the changing state of the Church; and discern common life together.

6.1.6 **Polity**

The Stated Clerk met with the pastor and leadership at First Presbyterian Church of Escanaba on October 28, 2019 regarding polity and attended a portion of the Committee on Ministry training held October 16, 2019.

6.1.7 The Stated Clerk continues to respond to inquiries regarding polity and church-related matters.

6.2 **Communications**

6.2.1 Email dated November 1, 2019, from the Rev. Jonathan H. Reinink, Church Support Associate for Special Offerings and Presbyterian Giving Catalog, Presbyterian Mission Agency, regarding the season of Advent and Christmas Joy along with the presbytery’s ten-year giving history to the Christmas Joy Offering. 9 **ADMINISTRATIVE COMMISSION FOR GRACE PRESBYTERIAN CHURCH OF SAGOLA**

Presbytery Moderator, Ruling Elder William Clark, reported that the

Session of Grace Presbyterian Church of Sagola has serious questions and concerns about the Presbytery of Mackinac and the Presbyterian Church (U.S.A.). Coordinating Council has recommended that an Administration Commission be formed to work with the church regarding their concerns. There being no nominations from the floor, on motion duly made and seconded Presbytery **VOTED** to elect Ruling Elders Lynn Dake, Daniel Maloch, and Karen Richards, and Rev. J. Kyle Segars and Rev. Gregory Zurakowki, the Administrative Commission for Grace Presbyterian Church of Sagola, to work with the church regarding their concerns.

10 **COMMITTEE ON BUDGET AND FINANCIAL SERVICES**

Committee Chair, Ruling Elder Edward Fines, reported verbally.

10.1 The Committee Chair stated the Committee members will miss Louis Fantini, his expertise, his wisdom, and his dedication.

Henderson and his wife have been dealing with health challenges and the Rev. Karen Zurakowski asked the Presbytery to hold them both in prayers for God’s perfect healing. She made a plea to pastors and elder commissioners, asking for a different sort of engagement with their congregations so that we help people meet the Holy Spirit. The Spirit may be calling people in their congregations to serve the Presbytery and the greater church, and asked their help in identifying them.
